Resolution; To consider, and if thought fit, to pass the following Resolution: That as from 1 January 2021 the annual subscription for 2021 shall remain the same as for 2020 being £960 per annum gross for family membership and £480 per annum gross for single membership. The Special Projects Fund rate will also be the same as for 2020 being £30 per annum gross for family membership and £15 per annum gross for single membership. That the Honorary Treasurers be empowered to establish gross payment amounts for Higher Rate taxpayers so that the net cost to them to be identical to that of standard rate taxpayers. That the Honorary Treasurers be additionally empowered to set reduced scale rates for young adults (18-35 years). Notes:

- (a) The annual subscription set out above will be the amount payable which remains as last year.
- (b) The Special Projects Fund levy shall be £15 per person which remains as last year.
- (c) Members will be invited to voluntarily pay £36 per annum into an EHRS lottery with a monthly winner.
- (d) The Board of Deputies voluntary contribution will be £15.00 per person as set by the Board of Deputies.
