



## THE ANNUAL GENERAL MEETING OF THE EDGWARE & HENDON REFORM SYNAGOGUE COMMUNITY WILL BE HELD ON SUNDAY 25 SEPTEMBER 2021 IN THE SYNAGOGUE MAIN HALL AT 10:00

We would like to draw your attention to the following:

1. Any matters which members would like to be included on the Agenda for the AGM must be received **in writing** at the Synagogue office (**addressed to the Office Manager**) by **12:30 on WEDNESDAY 30 JUNE 2021** and **must be signed by at least two members not of the same household**.
2. Nominations should be made using the enclosed form for candidates for election to the Council. Posts available for nomination are the eight Honorary Officers (Chairman, two Vice-Chairmen, two Honorary Treasurers, Honorary Secretary and 2 Honorary Officers without portfolio) and eighteen additional members of Council. Nominations should also be made using the enclosed form for the post of Junior Warden.

**All nominations require the signature of the nominee indicating willingness to be a candidate for the particular post, and must be signed (proposer and seconder) by two members not of the same household.** A photo of the candidate (which will be returned after scanning) **must** either accompany the nomination paper, or be supplied electronically (as jpg) to **admin@ehrs.uk**. Completed nomination forms and photo **must** be received at the Synagogue office (addressed to the Office Manager) by **12:30 on Wednesday 30 June 2021**. Please contact the Office Manager if you require additional nomination forms. **Kindly note that under Charity Commission rules neither Synagogue Employees, nor their spouses/partners, may stand for or be elected as an Honorary Officer or Council Member as Trustees are not allowed to financially benefit in any way from the Charity with the exception as shown in clause 7.1.3 of the Synagogue's Articles.**

3. Members' unmarried children over the age of 18 as of 25 September 2021 have the right to receive the Agenda and other notices for this AGM, to vote at this AGM and to be elected to the Council **provided that this right is registered in writing** to the Office Manager **before 12.30 on Wednesday 30 June 2021**.
4. Affiliates and Associates have the right to receive the Agenda and other notices for this AGM. They have the right and are welcome to attend the AGM. However, they do not have the right to vote at the AGM or to be elected to the Council.
5. The MINUTES of the Annual General Meeting held on 12 November 2020 were approved by the Council at their meeting held on Monday 8 December 2020 and are available for inspection at the Synagogue office (by appointment). Copies will also be supplied to members on written application enclosing a stamped addressed envelope, or by email (**admin@ehrs.uk**). Copies will also be available at the Meeting.
